

RESOLUTION NO. 6423

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF UPLAND
ADOPTING THE MASTER FEE SCHEDULE AND AMENDING
CITYWIDE FEES FOR THE COST OF SERVICES

Intent of the Parties and Findings

(i) California law requires that fees for City regulatory activities and services not exceed the estimated cost of regulation or providing the service for which the fee is levied and that no fee or service charge or increase in an existing fee or charge to which the fee or service charge be levied without the opportunity for the public to make oral or written comment at a regularly scheduled meeting of the City Council; and

(ii) The City Staff has incorporated the billable rates adopted by City Council on November 27, 2017 and performed an analysis of all fee-based regulatory activities and services; and

(iii) The fees set forth in the attached Master Fee Schedule and its exhibits do not exceed the estimated cost of the City's regulatory activities or the City's cost of providing services for which the fee is levied; and

(iv) The Upland Municipal Code permits the City Council to establish the fees and charges provided herein by resolution; and

(v) The proposed fees are based upon the information contained in the department specific documents prepared by City staff entitled "The User Fee Table" dated the 16th day of November, 2017 (the "Fee Table"); and

(vi) A copy of the Fee Report is on file in the City Clerk's office, and the Upland City Library and has been made available for public review in accordance with state law; and

NOW, THEREFORE, the City Council hereby finds, determines and resolves as follows:

Section 1. All of the above recitals are true and correct and are incorporated herein by this reference.

Section 2. The attached Master Schedule of Fees for Service and its various exhibits are herewith approved and adopted as the fees for various citywide regulatory activities and services.

Section 3. The City Finance Division shall be responsible for determining if any updates to this Master Fee Schedule are necessary and shall also be responsible for bringing such proposed updates to the City Council as needed.

Section 4. This resolution shall prevail over any existing resolution in the event of a conflict.

Section 5. The fees adopted by this resolution shall become effective on January 1, 2018 and shall remain in effect until repealed or amended, except for the fees identified in Section 6, below.

Section 6. Any residential project that has been issued building permits prior to the effective date of the new Master Fee Schedule and if said permits are still active on the effective date of the attached Master Fee Schedule, said residential project shall not be subject to said fee increases identified in the Master Fee Schedule for a maximum period of time of

12 months from the effective date of the Master Fee Schedule. Once the 12 month period expires, all building permit fees will be at the increased rates set forth in the Master Fee Schedule.

Section 7. Certification. The City Clerk shall certify the adoption of this resolution.


